JISU Department of Juridical Science did National Service Scheme work and Legal Aid Work in Narsinghapur and Devipur village, Police Station Duttapukur on 1st November, 2019, friday. There are many instances where the fertilizers are substandard and dont give adequate yield. Dr Souvik Chatterji told them that Legal Aid team of JISU gives free legal aid to everyone. Then Legal aid plays were acted out in D. Sussex Abaitanik Prathamik Bidyalay in Debipur village on child rights, free primary child education and ragging. It was reported in Ekhon Somoy Newspaper.

On 16th August, 2019, the Legal Aid Society of Department of Juridical Sciences, JISU performed Legal Aid Work at Baruipur Correctional Home (Shodhonagar). The permission for the Legal Aid Program was obtained from Justice Sri Kumar Goswami, (Judge, Alipore Sessions Court) and Mr Subhendu Krishna Ghosh (Superintendent of Baruipur Prison and Correctional Home). Legal Aid Speeches were given by Dr Souvik Chatterji (HOD, Law, JISU) on child rights, women's rights, prisoners rights and Article 21 of the Indian Constitution.





Under the Legal Aid Program, the Secretary, DLSA, South 24 Parganas, Justice Salim Ansari conducted the Legal Aid Camp. It was held in JISU Auditorium on 21st May, 2019 between 2 to 3 pm for LLB, BALLB and LLM students.



With the outreach Legal Aid Camp in Adyapith on 18th September and Contai and Digha in April, 2018, the Legal Aid Society of JIS University is advertised. Rural people in these districts are now aware of the law, their rights and type of Legal assistance, they will get from Legal Aid Cell JIS University.



Legal Aid Awareness work was carried out at Adyapith temple on 18th September, 2018. Speeches were given on rights Against child labour, right of maintenance of old people and dependants, rights of married women.
