3rd National Moot Court Competition on 29th July, 2024





On 29th July 2024, the Department of Juridical Sciences, JIS University, proudly hosted the 3rd National Moot Court Competition, the flagship legal event of the department. The competition saw enthusiastic participation from premier law schools across the country, including The West Bengal National University of Juridical Sciences, Maharashtra National Law University Aurangabad, UPES Dehradun, School of Excellence in Law (Tamil Nadu Dr. Ambedkar Law University), Symbiosis Law School Pune, Hooghly Mohsin College, St. Xavier's University Kolkata, Amity University Kolkata, and many other reputed institutes. JIS University also fielded two teams, proudly representing the School of Juridical Sciences. A total of 18 teams competed, and the rounds were judged by an esteemed panel including Justice Manas Kumar Paul, Justice Pradeep Kumar Banerjee, Justice Deep Biswas, Barrister Subrata Chakraborty, IPS Kalyan Mullick, Advocate Mukul Biswas, and Prof. Koyel Roy (HOD, Law, Amity University Kolkata). The competition consisted of three rounds, with six distinguished awards presented. The Octa-Finalists included teams from NUJS Kolkata, Symbiosis Pune, MNLU Aurangabad, UPES Dehradun, Tamil Nadu Dr. Ambedkar University, St. Xavier's University Kolkata, Hooghly Mohsin College, and JIS University. The Semi-Finalists were NUJS Kolkata, Hooghly Mohsin College, Tamil Nadu Dr. Ambedkar Law University, and JIS University. In the Researcher's Test, the candidate from UPES Dehradun was declared the Best Researcher, while the Best Memorial award went to Symbiosis Law School Pune. Nabendu Krishna Ghosh of St. Xavier's University Kolkata won the Best Speaker award. The Final Round was contested between NUJS Kolkata and Hooghly Mohsin College, with the latter emerging as the Champion, while NUJS secured the position of 1st Runner-Up. The team from Tamil Nadu Dr. Ambedkar Law University secured 3rd Position, and JIS University achieved a commendable 4th Position. The Valedictory Session was graced by Prof. Bhabes Bhattacharya (Hon'ble Vice Chancellor, JISU) and Prof. Rakesh Kumar Dhar Dubey, who also witnessed the semi-final and final rounds. The session was hosted by Dr. Souvik Chatterji (HOD, Law), and prizes were distributed by the Vice Chancellor. Faculty convenors Dr. Souvik Chatterji, Ms. Moumala Bhattacharya, Ms. Riya Banerjee, and Ms. Somdatta Mukherjee played pivotal roles in organizing the event.

The day concluded with a formal Vote of Thanks, marking the end of one of the most vibrant editions of the National Moot Court Competition, with a record number of national participants. The moot problem was drafted by Dr. Souvik Chatterji.

Half-Day Workshop Cum Seminar on the Paradigm Shift of Criminal Laws in India in collaboration with Legal Vision on 30th September 2024





On 30th September 2024, the NSS Unit, Legal Vision, and the Department of Juridical Sciences, JIS University, jointly organized a seminar on the Bhartiya Nyaya Sanhita (BNS), 2023 at the university campus in Agarpara, North 24 Parganas. The event saw active participation from LLB and BBA-LLB students of JIS University, as well as law students from JRSET College of Law. The seminar aimed to provide students with critical insights into India's newly enacted criminal law reforms and promote a deeper understanding of their implications.

The seminar began with a compelling presentation by Dr. Souvik Chatterji, HOD, Law, JISU, who conducted a thorough and analytical comparison between the Indian Penal Code (IPC), 1860, and the Bhartiya Nyaya Sanhita (BNS), 2023. He emphasized key changes in criminal procedures, especially the role of digital evidence, the importance of forensic science under the Bharatiya Sakshya Adhiniyam (BSA), and new procedural reforms under the BNSS. Dr. Chatterji highlighted progressive changes such as the inclusion of Zero FIR and discussed both the strengths and areas of concern within the new legislation, encouraging critical thought and dialogue among the students.

Miss Monika Kumari, Assistant Professor of Law at JRSET College of Law, was warmly welcomed as the Chief Guest. She delivered an insightful and detailed presentation, comparing the IPC, 1860 and the BNS, 2023, analyzing differences between key sections. She specifically addressed the contrast between Section 375 IPC and Section 63 of BNS, drawing attention to the evolving legal approach to sexual offenses. Her session also covered a range of significant topics such as capital punishment for gang rape, sedition, criminal defamation, unlawful assembly, acid attacks, human trafficking, bigamy, and more. Her critical perspective on the BNS reforms shed light on the shifting contours of India's criminal justice system.

Miss Kumari concluded her presentation by emphasizing the importance of evolving legal reforms that align with social and technological advancements, ensuring justice remains accessible, fair, and equitable. As a token of appreciation, Dr. Souvik Chatterji honored her with a shawl for her valuable time and contributions.

The seminar was highly enriching, providing students with in-depth knowledge of both historical and contemporary criminal laws. The NSS program outcome reflected the event's success, as attendees gained a detailed understanding of the transition from the IPC to the BNS and were encouraged to engage with legal reforms as future legal professionals.

<u>International Seminar on Future of Human Rights in South Asia in Mrinalini Dutta</u> <u>Mahavidyapith on 13th September 2024</u>





On 13th September 2024, Mrinalini Dutta Mahavidyapith, Birati, hosted an International Seminar on the Future of Human Rights in South Asia. The event brought together leading scholars and activists, including Dr. Souvik Chatterji, Head of the Department of Law, JIS University; Dr. Richard Benkin, journalist and human rights activist from the USA; and Professor Raj Kumar Kothari, Vice Chancellor of Sanskrit College and University, Kolkata. Dr. Sudeshna Lahiri, Principal of Mrinalini Dutta Mahavidyapith, opened the seminar by discussing the critical role of laws and government policies in shaping the future of human rights in countries across South Asia.

Professor Kothari emphasized that as the largest democracy, India has upheld the ideals of global human rights organizations such as Amnesty International. He also highlighted India's commitment, as a SAARC member, to improving the human rights situation within the region. Dr. Richard Benkin addressed ongoing human rights violations in countries like Bangladesh, noting that political instability and leadership changes often worsen the conditions.

Dr. Souvik Chatterji highlighted India's leadership in promoting and protecting human rights in South Asia. Citing Article 21 of the Indian Constitution, which guarantees the right to life and personal liberty, he discussed landmark Supreme Court cases such as Maneka Gandhi and Francis Coralie that expanded the scope of human rights. He noted India's progressive steps, such as providing equal wages to prison inmates and amending the Juvenile Justice Act in 2015 following the Nirbhaya case, allowing juveniles aged 16 to 18 to be tried as adults for heinous crimes. Dr. Chatterji also spoke on India's newly introduced criminal laws — Bharatiya Nyaya Sanhita, Bharatiya Nagarik Suraksha Sanhita, and Bharatiya Sakshya Adhiniyam — which aim to strengthen due process and enhance human rights protection.

The seminar also highlighted the academic collaboration between Mrinalini Dutta Mahavidyapith and JIS University, established through an MoU. This partnership has fostered several joint academic programs and seminars focused on key legal and social issues. The seminar concluded on a hopeful note, emphasizing the need for continued regional cooperation and legal reform to secure a better future for human rights in South Asia.

Anti-ragging seminar in Guru Nanak Institute of Dental Sciences and Research on 20th November, 2024





An anti-ragging seminar was organized at Guru Nanak Institute of Dental Sciences and Research (GNIDSR) on 20th November 2024. The event was attended by students, faculty members, legal professionals, and administrative authorities.

The seminar began with an address by the Principal, Dr. Jayanta Bhattacharya, who emphasized the institute's strict adherence to the Dental Council Regulations, 2009, which mandates a ragging-free environment in dental institutions. He proudly noted that GNIDSR has had no incidents of ragging on campus.

Alok Bajoria, Police Commissioner of Barrackpore Police Commissionerate, spoke about the seriousness of ragging-related offences. He assured students that in the case of any such incident, the Anti-Ragging Committee at GNIDSR would take immediate steps upon receiving a complaint. He also highlighted the role of the police in registering FIRs and conducting investigations to ensure justice.

Dr. Souvik Chatterji, Head of the Law Department at JIS University, explained the legal framework surrounding ragging. He discussed the definition of ragging, the applicable University Grants Commission (UGC) regulations, and relevant offences under the Bharatiya Nyaya Sanhita (BNS), formerly the Indian Penal Code. Dr. Chatterji listed several sections of BNS that can be applied in ragging cases, including provisions related to causing hurt, wrongful restraint or confinement, and culpable homicide not amounting to murder. He warned students that involvement in such activities could result in police or judicial custody, potentially damaging their academic and professional future.

He also explained the legal requirement for institutions to establish anti-ragging committees, which must include representatives from various sectors including police, civil society, parents, students, faculty, and non-teaching staff. Additionally, every student must submit an anti-ragging affidavit at the time of admission, signed by both the student and their guardian.

Dr. D. Banerjee, a member of the Dental Council of India, emphasized the importance of professional ethics and maintaining goodwill throughout a dental career. Dr. Soumitra Ghosh of GNIDSR shared the steps the institute has taken to create a safe and respectful environment for all students.

The seminar concluded with a strong message of zero tolerance for ragging and reinforced the commitment of the institute and authorities toward maintaining a safe and supportive academic space.

OUTREACH ACTIVITIES

NSS and Legal Aid Campaign at Vivekananda College on 29th November, 2024



On 29th November 2024, the NSS Unit of JIS University organized an NSS and Legal Aid Campaign at Vivekananda College, Thakurpukur, Behala. The event was a joint effort by the Departments of Juridical Sciences and Education, with the support of faculty, students, and volunteers. The campaign aimed to raise awareness about legal rights, provide educational support, and promote community involvement.

The program was led by Dr. Souvik Chatterji, Dr. Pritam Das, and Advocate Mit Guha Roy. It included legal awareness sessions, where students from the Law Department spoke about laws related to ragging, child protection, and key changes in the new legal codes—BNS, BNSS, and BSA. Legal consultation booths were also set up where members of the local community received free legal advice on issues such as property, family disputes, and workplace problems, under the guidance of legal professionals.

Meanwhile, the Education Department conducted a literacy drive and held basic classes for students, along with career counseling sessions to help them understand opportunities in the fields of law and education.

The event was a great success. It helped students from both departments apply their classroom learning in real-life situations and contributed positively to the local community. Over 100 students participated in the event and benefitted from the sessions. The support from Vivekananda College and the active involvement of the NSS Unit played a key role in the success of the program, which reflected JIS University's commitment to social service and holistic education.

<u>Legal Awareness Conducted By JIS University Law Students In The Madhyamgram</u> <u>High School On 1st October, 2024</u>

On 1st October 2024, the Law Department of JIS University, through its Legal Aid Cell and in collaboration with Legal Vision, organized a National Service Scheme (NSS) program at Madhyamgram High School to promote legal awareness among school children. The event received strong support from the school's Principal, Dr. Asutosh Ghosh, whose cooperation greatly contributed to its success.

The program began with an interactive lecture for Class VI students, delivered by Dr. Souvik Chatterji, Head of the Law Department at JIS University. He spoke on the importance of law and the Constitution, emphasizing how legal terms can be difficult to understand for ordinary citizens. He also highlighted the general lack of awareness regarding legal rights, which formed the core objective of this outreach effort. The students actively participated, engaging in a lively question-and-answer session following the lecture.

The next session, conducted for Class VIII students, featured two educational plays performed by students from the Department of Law. The first play addressed the issue of ragging, portraying a disturbing story of an engineering student who was mentally harassed by a senior and ultimately took his own life. The play followed the mother's legal struggle for justice, ending with the conviction of the senior student, who was sentenced to ten years of rigorous imprisonment. Dr. Chatterji guided the students through the legal procedures depicted, such as filing an FIR, police investigation, charge sheet submission, and courtroom trial.

The second play focused on child labour, presenting the life of a boy who was sold by his mother and forced into domestic work under a wealthy woman. The intervention of an NGO led to the child's rescue, and the woman was eventually sentenced to seven years of rigorous imprisonment. Dr. Chatterji explained the legal implications and the protection available under child rights laws. The play was brought to life by students including Ayusmita Chakraborty, Suchismita Palit, Kaushik Pahari, Priya Dey, Sarbani Chakraborty, and Shagufta Hussain.

The program was warmly received by the students, who showed great interest in the topics and asked insightful questions about legal procedures and their rights. The overall response reflected the program's success in spreading legal knowledge in simple and accessible language. It created awareness of issues such as the importance of law, the Constitution, the process of filing FIRs, and the protection of fundamental rights. As the students in these areas are often more vulnerable to legal challenges, the plays and discussions served as a powerful tool for understanding legal processes. The success of this initiative highlights the potential for more such outreach programs in the future to empower young citizens with legal awareness.

Visit to Calcutta High Court on 18th November, 2024



On 18th November 2024, 35 students visited the Calcutta High Court as part of an educational court visit. The list of students was approved by the Registrar of the Calcutta High Court, and official permission for the visit was sanctioned by the Chief Justice. The students first witnessed an appellate side proceeding in Court No. 8, where an appeal was being heard against a decision of the District Court, Alipore. The matter involved the nomination rights under a deceased's LIC policy. The appellant's counsel referred to a 2022 Supreme Court judgment affirming the nominee's right over the legal heirs in such cases.

The second proceeding took place in Court No. 16 and concerned the Companies Act, 2013. The issue revolved around whether a Holding Company had any binding legal authority over its Subsidiary. The original side counsel argued that the Memorandum of Association made it clear that the Holding Company had only persuasive influence, not legal control, and therefore bore no liability even if the interests of majority shareholders were overlooked. The third case, heard in Court No. 18, was an appellate matter against the State of West Bengal regarding irregularities in the TET exam. The challenge was made against a District Court order that directed payment of Rs 25,000 as costs to affected candidates. The appellant argued a lack of due process in the examination, and the two-judge bench scheduled the next hearing for the following month.

As part of the visit, the students were also taken to the Centenary Building of the High Court, where historical case records are preserved. Officer Subol Sardar showed several archival documents, helping students understand how legal records are maintained. Later, the students visited Court Nos. 11 and 12. Court 11, during the British period, functioned as a Sessions Court, and still retains the jury seating gallery used for jury trials, along with the place where executions once took place. This gave the students a glimpse into the colonial-era judicial system.

The visit highlighted the rich heritage of the Calcutta High Court, established in 1862 as the first High Court in India. At that time, appeals from the court went to the Privy Council in London. Today, the only appellate authority above the Calcutta High Court is the Supreme Court of India. The students also learned about the ceremonial role of the Sheriff in India, particularly in Kolkata and Mumbai, where the post still exists. Unlike in the United States, the Sheriff in India holds no law enforcement powers and serves symbolically to represent the city in official functions and promote civic initiatives. The visit offered students a valuable understanding of both the legal system and the historical significance of the High Court.

<u>Court Visit And Legal Aid At Additional District Judge, Diamond Harbour on 18th</u> <u>February, 2024</u>



As part of their practical legal education, the students of JIS University, School of Law, visited the Sub-Divisional Court of Diamond Harbour on a field trip designed to bridge the gap between theory and practice. The primary aim of the visit was to enhance students' understanding of the Indian judicial system, focusing on the functioning of Sub-Divisional Courts. The visit provided an opportunity to observe live courtroom proceedings, understand legal procedures, and interact directly with legal professionals including judges, advocates, and court staff.

During the visit, students witnessed hearings in both civil and criminal matters. They observed how cases are argued, how documentary and oral evidence is presented, and how judges apply procedural laws such as the Criminal Procedure Code (CrPC), Civil Procedure Code (CPC), and the Indian Evidence Act. The processes of examination-inchief, cross-examination, and re-examination were also demonstrated, helping students understand the practical aspects of trial advocacy. Students also gained insights into court documentation including FIRs, charge sheets, bail applications, and the overall case management system. Legal professionals took time to explain courtroom etiquette, the importance of legal research, and the ethical responsibilities of future lawyers.

A special session was held where Hon'ble Additional District Judge Sj. Jai Prakash Singh delivered a lecture on the new criminal law reforms — Bharatiya Nyaya Sanhita (BNS), Bharatiya Sakshya Adhiniyam (BSA), and Bharatiya Nagarik Suraksha Sanhita (BNSS). He particularly emphasized the importance of cross-examination and the evolving role of legal practitioners under the new legal framework. Students were also introduced to alternative dispute resolution mechanisms and learned about the role of Lok Adalats in reducing case backlogs.

The visit proved to be an enriching experience, deepening the students' understanding of court hierarchy, courtroom conduct, legal argumentation, and the challenges of case pendency in the Indian judicial system. Through this initiative, students could connect theoretical classroom learning with real-world practice, thereby developing essential legal, observational, and ethical skills. <u>Inter-College Quiz and Debate Competition on the Ocassion Of Constitution Day on</u> <u>26th November, 2024</u>





On 26th November 2024, the Department of Juridical Sciences, JIS University, organized an Inter-College Debate and Quiz Competition to commemorate Constitution Day, marking the adoption of the Indian Constitution and promoting its values of justice, liberty, equality, and fraternity. The Quiz Competition tested students on the Constitution's drafting, key provisions, and relevance to contemporary issues, with Sk Nayeem (JISU) winning first prize and Seherul Islam and Mahenoor Ashrafi (JISU, 2nd year LL.B) securing second place. The Debate Competition, on the topic "Reservation: A Bane or a Boon," showcased sharp reasoning and advocacy skills. Tirthom Ghosh (George School of Law) won first prize, followed by Sumanta Ghosh (1st Year LL.B, JISU) in second, and Tania Mondol, Athai Mondal (Mrinalini Dutta Mahavidyapith), and Aksa Khan (1st Year BBA LL.B (H), JISU) in third place.

Chief Guests Dr. Anuja Gupta and Debajan Mitra delivered inspiring speeches on youth engagement and the role of the Constitution in modern governance. Dr. Chatterji and Dr. Kundu concluded the event with a vote of thanks. The program was a resounding success, enhancing students' understanding of constitutional history, fostering public speaking and analytical skills, and encouraging a strong sense of civic responsibility.

Dr. Arup Poddar focused on the relevance of IP laws in today's world, especially in relation to traditional knowledge and cultural heritage. He explained how IP laws can be used to protect indigenous practices, folk art, and biodiversity from being misused. Dr. Poddar encouraged students to explore research and entrepreneurial opportunities in these areas and stressed the value of respecting and preserving traditional knowledge through legal means.

The workshop helped participants gain a better understanding of how intellectual property works, why it matters, and how it can be used in both academic research and entrepreneurial ventures. It also provided insights into filing for IP protection, the role of IP in innovation, and how startups can use IP rights strategically to grow.

The celebration of World IPR Day at JIS University proved to be a meaningful and informative experience for everyone involved. It promoted a deeper appreciation for the value of intellectual property and encouraged students and faculty to think more creatively and protect their original ideas.
